

more chemicals for spice and 19 more for bath salts have been added to the list of illegal drugs.

In response to Mayor Cobb's inquiry, Ms. Wood stated there currently is not a clearinghouse that lists the names of chemicals that are being utilized in the synthetic drugs. She stated the State currently has a running list but does not list all the drugs.

In response to Commissioner Sena's inquiry, Ms. Wood stated she has been coordinating with Ms. Kathleen Moran, an attorney representing Lea County, regarding synthetic drugs who plans to utilize the City of Hobbs' ordinance as a model tool to fight the drug problem in Lea County.

In response to Mayor Cobb's inquiry, Ms. Wood stated the ordinance will have to be updated periodically to include new chemicals that manufacturers create.

Commissioner Buie thanked Ms. Wood for a job well done.

Mr. Stone stated Ms. Wood has done an outstanding job on the synthetic drug problem. He stated she has a J.D. and a M.S. in Toxicology.

There being no further discussion, and no comments from the audience, Commissioner Mullins moved that the Commission publish notice of its intent to adopt the ordinance at a later date. Commissioner Newman seconded the motion and the vote was recorded as follows: Buie yes, Calderón yes, Mullins yes, Sena yes, Boyd yes, Newman yes, Cobb yes. The motion carried.

FINAL ADOPTION: Ordinance No. 1058 - Amending Chapter 2.56 of the Hobbs Municipal Code Relating to Personnel Rules. Mr. Toby Spears, Acting City Manager, explained the proposed ordinance relating to Personnel Rules and Personal Time Off (PTO). He explained the buy down process of existing leave and future accruals of PTO. He stated the accrual of PTO has been established on a three-tier basis, 1 to 5 years, 6 to 15 years and 16+ years. He stated by keeping an established PTO cap number and paying down future PTO liabilities in the year they occurred, the City becomes more fiscally responsible for future budgets.

Mr. Stone stated the ordinance in the packet is incorrect and gave his apologies.

In response to Mayor Cobb's inquiry, Mr. Stone stated the ordinance posted on the City website from the December 17, 2012, meeting is correct.

There being no further discussion, and proper publication having been made, and there being no public comment, Commissioner Sena moved that Ordinance No. 1058 be adopted as presented. Commissioner Mullins seconded the motion and the vote was recorded as follows: Newman yes, Calderón yes, Mullins yes, Buie yes, Boyd yes, Sena yes, Cobb yes. The motion carried. Resolution No. 5934 - Authorizing the Mayor to Ratify a Memorandum of Understanding with the Hobbs Police Officers' Association Relating to Paid Time Off.

Resolution No. 5935 - Authorizing the Mayor to Ratify a Memorandum of Understanding with the Hobbs Professional Firefighters Association Relating to Paid Time Off. Mr. Stone stated the City will be implementing a PTO system for all non-union employees. He stated Hobbs Police and Fire Unions have voted to join the City's PTO system. Mr. Stone stated these resolutions will allow the Unions' collective bargaining agreements to be amended to allow the union members to be included in the PTO system.

Commissioner Boyd moved that Resolutions No. 5934 and 5935 be approved as presented. Commissioner Newman seconded the motion and the vote was recorded as follows: Sena yes, Boyd yes, Newman yes, Calderón yes, Mullins yes, Buie yes, Cobb yes. The motion carried. Copies of the agreements are attached and made a part of the minutes.

Mayor Cobb commended Mr. J. J. Murphy, City Manager, and City staff for working together on the PTO program which benefits everyone involved.

Reconsideration of Action Regarding a Request for a Waiver of Distance Requirement for a Proposed Alcohol Licensed Premises Known As Buffalo Wild Wings at 1120 Joe Harvey Blvd. Mr. Stone stated AlamoWing Hobbs, LLC, requested a waiver of distance requirements for a Buffalo Wild Wings to be located at 1120 Joe Harvey Blvd. He stated the City Commission denied the request at the Commission meeting held on December 17, 2012. Mr. Stone stated he received a letter from AlamoWing Hobbs, LLC, requesting the Commission to reconsider denial of the variance. He stated, as per the Hobbs Municipal Code, the Commission has the right to reconsider the action. Mr. Stone explained the criteria and stated the motion must be made by a member who
